INTRODUCTION

St. Joseph FertilityCare Center Practitioner Education Program is directed by Angelique Garcia, BSE, CFCE, and is located in Albuquerque, New Mexico, USA. This center has trained practitioners in the **CREIGHTON MODEL FertilityCare™ System** for more than 30 years, in the USA, Mexico, and throughout Europe.

The **CREIGHTON MODEL FertilityCare™ System** was developed by Thomas W. Hilgers, MD, CFCMC, in response to Pope Paul VI's challenge to "physicians and health care professionals" and to "men of science," in his encyclical letter *Humanae Vitae* (Human Life). Dr. Hilgers is the Director of the Pope Paul VI Institute for the Study of Human Reproduction, which is the leading education and research center in the United States in the area of natural regulation of human fertility & the development of morally and professionally acceptable reproductive health services.

FERTILITYCARE PRACTITIONER PROGRAM

This **13-month course** includes two education phases conducted in Paris, France, two (2) supervised practica & an On-Site Visit completed at the student's home location. Supervision is provided through an innovative system of long distance monitoring & an On-Site Visitation by the Intern's supervisor, near the end of the second practicum. The program includes education in both the **basic** as well as the **advanced** aspects of teaching the **FertilityCare System**. The student must teach at least 18 clients over the course of the 13-month program.

All students enrolled in the program are required to take a criterion referenced, professionally administered final certificate examination, following successful completion of the two education phases & two supervised practica.

Education phase I (EP-I)

The first education phase is an **nine (9) day total-immersion format**. This structured experience develops basic teaching skills. There is a mid-EP exam and a final written exam. Successful completion of EP-I qualifies the intern for entrance into Supervised Practicum I (SP-I). Interns will begin teaching couples under faculty supervision within two weeks of completing EP-I.

Supervised Practicum Phase I (SP-I)

The program involves a faculty **supervised clinical experience**, which is six (6) months in duration and is to be completed at the intern's home location. Assignments are submitted to the interns supervisor via email or fax. A phone call / skype call is required every month to offer support and guidance to the intern. The intern must teach a minimum of 6 client couples & complete assignments satisfactorily in order to qualify to attend EP-II in May 2011.

Education Phase II (EP-II)

This second education phase is a **six (6) day total immersion format**, consisting of lecture, clinical group discussion and hands-on problem solving of the advanced aspects of teaching the **CREIGHTON MODEL FertilityCare™ System**. This phase ends with a visual and theoretical oral examination.

Supervision Phase II (SP-II)

This second **supervised clinical experience** is seven (7) months in duration and occurs at the intern's home location. The clinical aspects of this supervised practicum are devoted to learning advanced teaching skills. An On-Site Visit (OSV) is part of this supervision phase.

On-Site Visit (OSV)

In addition, SP-II includes an **On-Site Visit** by a member of the St. Joseph FertilityCare Center faculty. The intern must teach a minimum of 12 client couples & complete assignments satisfactorily in order to qualify for the on-site visit. At the On-Site Visit the following will be reviewed:

- Introductory Session Critique and Review
- Follow-Up Critique and Review
- Tour of Facilities
- Comprehensive Case Review

Final Exam

The Practitioner certificate examination is given in **November**. In order to qualify for the final exam, the intern must complete all assignments satisfactorily and teach a minimum of 18 couples.
